Nilai U and **UPM** collaborate

NILAI University (Nilai U) and Universiti Putra Malaysia (UPM) have signed a Memorandum of Understanding for academic collaboration.

The MoU will allow arrangements for the conferment of dual and double awards by both institutions.

The first such arrangement is for a Master's in Agricultural Management.

Students who complete a Master's programme in one university may opt to complete additional modules at the other university to obtain a second Master's award.

Nilai University will draw on the expertise of its current Biotechnology department and Business faculty as well as that of its shareholder, Felda Global Ventures (FGV) Holdings Berhad, to develop the Master of Business Administration in Tropical Plant Management programme.

The agreement will also see both institutions working closely in areas such as student exchange, internship, research and academic attachments.

The MoU was signed by UPM vice-chancellor Prof Datuk Dr Mohd Fauzi Ramlan and Nilai U vice-chancellor Prof Datuk Dr Sothi Rachagan.

It was witnessed by Nilai U Council member and head of Group Corporate Strategy Planning of FGV Muhammad Hudhaifa Ahmad and the Dean of UPM School of Graduate Studies Prof Dr Bujang K Huat.

According to Prof Sothi, the MoU was a culmination of years of working closely with

Prof Sothi also thanked Prof Fauzi for his generous support for student development programmes organised by Nilai U, including the Future Leaders Camp, 1World Culture and Youth Empowerment Symposium held each year.

private and public institutions.
