



ABSTRACT

The satisfaction of visitors to the park depends highly on what the benefits they get from the facilities of the park. This study was conducted to assess the satisfaction level of visitors on facilities at Pudu Ulu Recreation Park, Cheras and factors influencing their satisfaction level. In this study, descriptive and regression analysis were used to achieve the objectives. Result show that, among all the facilities provided in the park, the location of gazebo was found to have the highest of satisfaction while the number of kiosks in the park was rated the lowest level of satisfaction. Factors influencing the level of satisfaction are race, specifically the race Indian and Malay.



ABSTRAK

Kepuasan pengunjung ke taman sangat bergantung pada apa manfaat yang mereka dapat dari kemudahan di taman tersebut. Kajian ini dijalankan untuk menilai tahap kepuasan pengunjung terhadap kemudahan di Taman Rekreasi Pudu Ulu, Cheras dan faktor-faktor yang mempengaruhi tahap kepuasan mereka. Dalam kajian ini, analisis deskriptif dan regresi digunakan untuk mencapai matlamat. Keputusan menunjukkan bahawa, di antara semua kemudahan yang disediakan di taman ini, lokasi gazebo didapati mempunyai kepuasan tertinggi manakala bilangan kios di taman itu dinilai pada tahap kepuasan yang paling rendah. Faktor yang mempengaruhi tahap kepuasan adalah kaum, khususnya kaum India dan Melayu.



Visitor satisfaction can be defined to many perspectives, including international visitors, domestic visitors, managers, experts and agencies. Measures the satisfaction of visitors providing feedback to meet and exceed visitors' expectations for identifies that areas where can do improvements. Visitor satisfaction can be measured in various ways from listening to casual comments made by visitors, using comment boxes, focusing on groups, and short or broad questionnaire surveys. Different approaches can be divided into quantitative and qualitative that have strengths and weaknesses, when used strategically together they complement each other.

1.2 Problem Statement

The main purpose of this study is to highlight the visitors' satisfaction levels on the facilities in Pudu Ulu Recreation Park.
